INTRODUCTION

The Law collection is adequate to support the courses taught in numerous bachelor's, master's, and doctorate programs. Complete conspectus sheets and checklists are available upon request for a more detailed collection examination.

HOLDINGS

The Law collection contains **13,256** titles in the **K** call number range, including 10,568 ebooks. Total monograph expenditures for Law (K call number ranges) from FY 2017-2018 to FY 2022-2023 were **\$84,722.78** with 761 new titles added. These newer additions comprise 5.74% of the current Law collection.

The following numbers represent a snapshot of the collection as titles are continually being added and withdrawn for collection maintenance and growth. These numbers do not represent additional titles available through e-book databases.

PERIODICALS AND SERIALS

There are over 2,900 journals available electronically in Law, which can be found in EBSCO's Publication Finder at http://bit.ly/2z06DjD and via the Library's database subscription --- Westlaw. The Serials expenditures in Law (including Political Science) for print and electronic subscriptions and standing orders were \$58,355.85, from 2017 to 2023 (see table below).

This collection is central to the University curriculum since it directly supports studies in Applied Engineering, Business, Communication, Criminal Justice, Education, Emergency Management, Environmental Sciences, Family and Consumer Sciences, History, Kinesiology, Nursing, Political Sciences, Pre-Law, Social Work, etc. Complete conspectus sheets are available for a more detailed examination of the collection.

Total monograph expenditures for Law (K call number ranges) from FY 2017-2018 to FY 2022-2023 were **\$84,722.78** with 761 new titles added. SUMMARY

Strengths:

Total holdings, conspectus evaluation, and checklist comparisons indicate the overall Law collection is adequate to support the curriculum. Of note on the conspectus worksheets are the holdings in the subject areas of "Law in general. Comparative and Uniform Law. Jurisprudence" (K1-7720), "Law of the United Kingdom and Ireland" (KD), and "Law of the United States" (KF) are adequate.

Hundreds of new titles were added under sub-categories KF for curriculum support since the last assessment in 2017. The following sub-categories are strong:

- Congressional documents (KF12-49),
- Statutes and administrative regulations (KF50-90),
- Law reports and related materials (KF101-153),
- Criminal trials (KF219-224),
- Civil trials (KF226-228),
- Legal research. Legal bibliography (KF 240-247),
- Legal education (KF261-292),
- The legal profession (KF297-334.2),
- Persons (KF465-553),
- Contracts (KF801-1241),
- Torts (KF 1246-1327),
- Regulations of industry, trade, and commerce (KF 1600-2940),
- Intellectual property (KF 3195-3198),
- Social legislation (KF 3195-3198),
- Food. Drugs. Cosmetics (KF 3861-3896),

- Education (KF4101-4330),
- Constitutional law (KF 4501-5130),
- Courts. Procedure (KF 8700-9075),
- Criminal law (KF 9201-9461),

The number of eBook titles in the K call number range increased dramatically with the addition of thousands of titles since the last assessment.

A review of the journal holdings reveals that the Law collection is more than adequate to support the curriculum with a high quality.

Subscriptions to law-related databases in the Library, such as Westlaw, LegalTrac, Gale Legal Forms, govinfo, and CQ Press Library, significantly improve access to valuable resources.

Weaknesses:

While no specific weak areas were specified in the Conspectus, the collection for the following sub-categories should be kept up-to-date:

- Public health. Sanitation (KF 3775-3816)
- Medical legislation (KF3821-3838)
- Public safety (KF3942-3977)

It is worth noting that there are several sections within the collection characterized by single-digit holdings. While these areas are not explicitly labeled as out of scope in the conspectus, they are not identified as weaknesses either. This distinction is important, as these specific segments of the collection do not primarily serve as curriculum support.

Recommendations:

The growth rate of the Law collection should be maintained to continue providing support for curriculum and research support in the bachelor's, master's, and doctorate programs at JSU. The monograph collection should be generally increased, based on budget, with a strong focus on core and outstanding titles. The substantial periodical collection accessible through databases should be preserved and adequately maintained. Furthermore, given the FDsys retirement and transition to GovInfo, a comprehensive study is required to assess its resources and availability. A significant amount of time will be allocated to the evaluation of both the onsite print version and

its corresponding electronic counterpart for the purpose of updating, linking, or withdrawing, in order to meet local requests effectively.
